

2018 Philadelphia Union *PAWS ON THE PITCH*
WAIVER AND RELEASE FORM
READ CAREFULLY – THIS CONTAINS A WAIVER OF LIABILITY

By attending *PAWS ON THE PITCH* (the “Event”) with a dog, you hereby agree:

- To indemnify and hold harmless Keystone Sports & Entertainment LLC, Pennsylvania Professional Soccer LLC (d/b/a Philadelphia Union) (“Union”), F.C. Pennsylvania Stadium LLC, (d/b/a Talen Energy Stadium), KSE U2 LLC, BPG Land Partners VIII entities, The Delaware County Chester Waterfront Industrial Development Authority, Major League Soccer, L.L.C., Soccer United Marketing, LLC, Global Spectrum, LP, the respective subsidiaries and affiliates of each of the foregoing entities, and all of their respective direct and indirect, past, present and future officers, directors, members, managers, shareholders, partners, owners, agents, representatives, attorneys, employees, sponsors, licensees, contractors, successors and assigns (collectively, the “Parties”) from any and all claims of liability and damages arising from any injury, property damage, loss, claim, or expense that may occur to you and/or your dog while attending the Event;
- To indemnify and hold harmless the Parties for any injury that occurs to any person, other dog, or property as a result of the behavior of your dog, whether expected or unexpected, regardless of the stimulus for the behavior (i.e., dog’s spontaneous conduct, the conduct of another dog, the conduct of any person or thing, or a combination of any of these);
- To accept sole liability for any injury, property damage, loss, claim, or expense resulting from the behavior of your dog;
- To report any and all such injuries immediately to an Event staff member;
- That in bringing your dog to the Event, you understand that you are doing so at your sole risk, cost and expense, and any harm that comes to the dog shall be solely your responsibility;
- That you are solely responsible for maintaining control over your dog at all times;
- That you are solely responsible for cleaning up any messes made by your dog;
- That if your dog acts in any way considered aggressive or dangerous, you will leave the Event and will not be entitled to any refund.
- That, in connection with any injury you or your dog may sustain or other medical condition you or your dog may experience during your participation in or attendance at the Event, you

authorize any emergency first aid, medication, medical treatment, or surgery deemed necessary by the attending medical/first aid personnel if you are not able to act on your own behalf.

- That the Philadelphia Union; Global Spectrum, LP; FC Pennsylvania Stadium, LLC; and Keystone Sports and Entertainment Company, or any other party involved with the Event, may produce, reproduce, broadcast, and otherwise use photographs, films, videotapes, recordings, digital images and other depictions, likenesses, or images of you and your dog, in any media form, worldwide, in connection with your attendance at or participation in the Event without compensation, for an unlimited duration and you agree to release each such party from any and all liability in connection with it doing so.

I, intending to be legally bound, have carefully read and voluntarily agree to this Waiver and Release and I understand its full legal effect.
